1. **West Raleigh Hyatt Place** – 6-story, 132-room, LEED Certified, hotel located at 710 Corporate Center Drive, Raleigh, NC, 27607. Contact: Bob Ray, HJH Associates, 770-497-4570, r1ay@aol.com.  
**STATUS:** Under construction. Expected opening January 2012.
2. **Springhill Suites** – 86,394 sq. ft. hotel to be constructed at 1716 Walnut Street in Cary. Developer is CMC Hotels, 5640 Dillard Dr., #300, Cary, NC 27518, 919-462-3400. (Days Inn Cary...site of old hotel officially closed on July 11, 2010.)  
**Status:** Construction currently on hold (11/11).
3. **Hampton Inn & Suites** – 6 story, 135 room property located on Glenwood Ave., at I-440. Developer is Winwood Hospitality. Contact is Amit Patel, Winwood Hospitality, Morrisville, (919) 468-9190.  
**Status:** Land has been cleared. Proposed opening date in 2012/13.
4. **Hampton Inn South Glenwood** – 126-room, 6-story Hampton Inn & Suites located on the corner of Glenwood Ave. and Johnson St. in Glenwood South. The hotel would have 1,408 square feet of meeting space and 950 square feet of retail space. **Status:** Under construction/land cleared. Proposed opening in Fall/Winter 2012-13.

**Aloft Hotel at Brier Creek** – 5-story, 150-room hotel with 1 meeting room located at 10020 Sellona St., Raleigh 27617. Developer is NARSI Properties, (704) 400-6020.

**STATUS:** Preliminary site plan filed on 9/11/08. No further action at this time.

**eSuites Hotel** – Located at 111 TransAir Dr. (off Airport Blvd) Morrisville. eSuites are technology-rich boutique hotels. 8 Story, 224 room with pool and fitness center. Two room guest suites will be 460+ sq. ft. Hotel will offer free internet service, advanced-technology business center, on site restaurant, fitness complex and complimentary use of a Lincoln Town Car or Navigator for local transportation. **STATUS:** No action on this project.

**Aloft Hotel RDU** – \$18.9 million, 151 room hotel to be built adjacent to the Hilton Garden Inn at RDU International Airport. Hotels are characterized by exposed beams and structural steel, guest rooms with 9-foot ceilings and oversized windows, wireless connectivity and high-tech entertainment centers. **STATUS:** No action on this project.

**Forty-Wade Project** – 168 acre mixed use development across Edwards Mill Road from the RBC Center. The site has plans for a 300 room, 10-story hotel along with 1400-1800 town homes, condominiums and apartments. There is also 500,000 square feet of office space and 150,000 retail space.

**STATUS:** Project approved by Raleigh City Council on May 16, 2006. This project has been changed and hotel may no longer be part of project.

**5401 North** – Located at the interchange of US 401 and I-540. Mixed use development of 1200-1400 homes, apartments, along with 1.6 million square feet of offices, retail, restaurants, movie theater, plaza area for concerts and a 250 room hotel. **STATUS:** No action on this project.

**Drury Inn & Suites** – located at White Oak Crossing, northwest quadrant of I-40 and US Hwy 70 in Garner. Approximately 150 rooms; may have meeting space. **STATUS:** No action on this project.

**Aloft/Hampton Inn** - located on one-acre block bounded by Hillsborough, Edenton, West and Harrington streets. Project would have two different hotels under one roof...Aloft and Hampton Inn. Aloft would have 80 rooms and the Hampton Inn would have 120 rooms. In addition to the two hotel brands the project could also have 200-250 condos as part of the project. With the condos the structure would be 22-25 stories high. Without the condos the project would be half as tall. If project is approved construction could begin in early 2008 and completed by 2010. **STATUS:** No action on this project.

**Crowne Plaza Hotel** – Located at 251 Airgate Dr., Cary, currently site of the I-40 Park & Fly facility. Projected to be a 200 room hotel, 12,000 square foot ballroom and 2,000 square feet of meeting space. **STATUS:** As of 6/27/11 this project is on hold.

**Park West Village** – Located at 9705 Chapel Hill Rd., Morrisville (southwest corner of Cary Parkway and NC 54 Intersection). **Powerhouse Plaza** – This would be a 10 story project with ground floor shops and restaurants, 85,000 square feet of office space, 400 parking spots and 134-room hotel and rooftop bar (to occupy 5 stories of building). **Raleigh Hotel and Innovation Park (BHPS Hospitality Group)** – a proposed 368-room hotel located at Trinity and Edwards Mill Road near Carter Finley Stadium and RBC Center. The proposed full-service, luxury hotel would include presidential and junior suites, club level, kid's suites, 20,000 square feet of meeting space, 10,000 square foot spa.
